





In a statement almost no one believed, President Obama had this to say the other day about the breathtaking advance of Sunni militants in western Iraq:

"I don't rule out anything, because we do have a stake in making sure that these jihadists are not getting a permanent foothold in either Iraq or Syria."

### There will be a solution!

• The Cyprus Problem is becoming insignificant in the new World Order

- The Americans and the West have much more pressing problems to allow Cyprus to spoil their effords
- The Americans and the West need some stability in the Region
- For stability they need to mend relations between Israel, Turkey and Egypt
- They need to end Greco-Turkish tensions thus, solve the Cyprus Problem

Hydrocarbons

- Probably insignificant as a World Resource
- Significant enough (at least in the minds of Cypriots) to lubricate the talks

### There will be a solution!

• A 'solution' does not necessarily mean Reunification

- $\circ\,$  Obviously, a peaceful reunification is the preferred option
- If this is not possible, other, more violent 'solutions' will be considered
- The economic crisis is already changing the minds of everybody

• In extreme despair, a new armed conflict cannot be ruled out

 In the South the 'rejectionist' front is weakening but small hardcore nationalist groupings are beginning to emerge

### Varosha at the forefront

- If there is movement towards a solution, Varosha will be at the forefront
  - Varosha as part of the solution It is probably equally difficult to agree on the 'modalities' of the return of Varosha to its owners as it is to solve the Cyprus Problem
  - Varosha as part Confidence Building Measures Probably the most important aspect of the return of Varosha will be the goodwill it will create among the population and the optimism it will create
  - In exchange for Varosha it will be easy to break old taboos and open the Famagusta harbour and probably Ercan airport

### Varosha at the forefront

- Whatever the case we should be preparing for the opening of Varosha
  - Preliminary studies environmental, safety, data collection
  - Short term planning temporary infrastructures, emergency plans, logistics of resettlement
  - Medium and Long term planning a Vision for Famagusta, town planning, logistics of reconstruction

#### The Fenced City

• Town planning provisions. Do the 1974 rules apply?

- Providing infrastructure
- Rules and guidelines for reconstruction
- Who will pay for the reconstruction?
  - Private and Public funding
  - Is there a 'loss of use' issue?

#### • The logistics of Resettlement

- Development of an Emergency Plan

  - Building permits for repairs and refurbishment
  - Permits for demolition and rebuilding
  - New codes: fire and earthquake resistance requirements

# The resettlement of the Fenced City

- Imposing solutions does not go down well
- No formula, however complicated, can take care of all situations
- Complicated formulae scare off people and are exploited by populists and nationalists
- People will not be satisfied if they don't decide themselves for their affairs – especially their property
- Empower people to make that choice within the bounds of a few simple rules they can understand and accept

### The resettlement of the Fenced City

• The Centralised Top-Down scenario

- Assume control of the City, clear the area and assess building safety
- Establish Municipal authority
- Decide which buildings are worth preserving and demolish the ones that are beyond repair
- Redesign the City with a modern town planning outlook
- Undertake extensive land consolidation reforms
- Reconstruct old and create new infrastructure networks
- Return the City to its inhabitants

### The resettlement of the Fenced City

#### • The de-Centralised Bottom-Up alternative

- Assume control of the City, clear the area and assess building safety
- Establish Municipal authority
- Allow the return of owners to their properties
- Reconstruct old and create new infrastructure networks
- Let the owners decide on the fate of their buildings in line with a few simple rules:
  - Restoration can proceed almost without any new requirements
  - New construction or modifications should follow a new City Plan

### The resettlement of the Fenced City

The Centralised Top-Down scenario

#### o <u>Advantages</u>

- Allows for rational planning
- Creates a modern city
- There are very few uncertainties

#### o <u>Drawbacks</u>

- People will not relate to it it could even be impossible to implement
- It is prone to abuse and corruption

#### The De-centralised Bottom-Up alternative

#### o <u>Advantages</u>

- It allows owners to access quickly their properties
- Owners decide for themselves the fate of their properties
- More accountability
- o <u>Drawbacks</u>
  - There will be individual grievances
  - Allows the old to dictate the form of the new

#### Do we trust each other?

• What if everybody wants to return?

- What if everybody refuses to move?
- Possibilities of abuse or political sabotage
- Big landowners and property developers

 In the final analysis, the sustainability of a solution has to be based on mutual trust

 We cannot guard against every eventuality on the premise of the other's untrustworthiness

#### More on the Fenced City

- I can see no rational reason why the Fenced City of Famagusta should remain deserted
- The City can easily be returned to its inhabitants in a way that does not offend their sensitivities
- It is imperative that scientists and engineers be given access to the city immediately in order to study it and create a basis for future planning
- Joint research groups could provide a vehicle for such studies in order to avoid political objections or misunderstandings
- European Academic institutions (including Greek and Turkish ones) would be interested in taking part in such research projects

European funding should be easily obtained

#### Extrapolating...

- Can the same principles be applied to the property issue in general?
- The Centralised Solution Resolve every issue through detailed discussion of all possible situations
  - This has been the approach up to now with very mixed results
  - It is doubtful whether anyone understood the provisions of the Anan Plan in a comprehensive and meaningful way
  - People were asked to take on trust the analyses of the politicians. These analyses were mostly propaganda for 'yes' or 'no' rather than honest assessment of the realities of the property proposals

#### Extrapolating...

- The de-Centralised alternative Establish a few simple, easily understood principles and let the people decide for themselves
  - Fully recognise the right of ownership and its exercise
  - The exercise of the right of ownership should cause no undue distress to present users
- Set a time-frame for the resolution of possible conflicts
- Set up a property commission to mediate in conflicts
- Provide incentives and encourage joined development ventures
